* Includes all Medicare beneficiaries who were enrolled in Medicare on or after January 1, YYYY.

† Member years of enrollment is calculated as the cumulative member months of Part D enrollment for all beneficiaries, divided by 12 (months).

▲ Beneficiaries with full or nearly full fee-for-service coverage (the beneficiary had 11 or 12 months of both Part A and Part B fee-for-service coverage, or for persons who died during the year, from January 1 until the month before death occurred), in addition to at least one month of Part D coverage.

‡ Employer/Union Only Direct plans. This category does not include employer plans that contract with other entities to provide the Part D benefit.

∞ "Other" plan types include national PACE and demonstrations.

** Derived from the cost-share group field; includes beneficiaries who were deemed (dual Medicare & Medicaid), had low income subsidy (LIS), or no subsidy.

‡# Where category totals do not sum to the total sample, there may be a small number of 'unknowns'.

♦ Race variable is calculated using the RTI race categories. Note that this differs from the race variable for CCW web table A1a.

● Age is calculated based on the age of the Medicare beneficiary as of December 31, YYYY. If the beneficiary expired, the age is calculated based on age at the time of death.
