** The Chronic Conditions Warehouse (CCW) team calculates member years of enrollment as the cumulative member months of Part D enrollment for all beneficiaries, divided by 12 (months).

† Beneficiaries with full or nearly full fee-for-service (FFS) coverage (the beneficiary had 11 or 12 months of both Part A and Part B FFS coverage, or for persons who died during the year, from January 1 until date of death), in addition to at least one month of Part D coverage.

‡ MA-PD plans include both local and regional plans. “Other” plan types include national Program of All-Inclusive Care for the Elderly (PACE) and demonstrations. The Employer/Union only direct plans category does not include employer plans that contract with other entities to provide the Part D benefit.

▲ Derived from the cost-share group field; includes beneficiaries who CMS deemed dually enrolled in Medicare and Medicaid, had low income subsidy (LIS), or no subsidy.

Where category totals do not sum to the total sample, there may be a small number of “unknowns.”

^ The CCW team calculates race variable using the Research Triangle Institute (RTI) race categories.

¶ The CCW team calculates age based on the age of the Medicare beneficiary as of December 31, YYYY. If the beneficiary expired, the CCW team calculates age based on age at the time of death.
